- 2. Delivery methodology<sup>ii</sup>. Client-centred learning. ### The problem

Australian research shows diving instruction has for 50 years<sup>iii</sup> been an inadequate system to train learner drivers, in fact it has shown to increase the crash risk in many teenage groups, with little to no impact when training disabilities or specialised needs. A system that uses Telling tips and tricks to pass a test is not a training system, no matter how many times you say it "Driving Instructors receive as little as 30 mins in car training", and have No standardised curriculum or delivery system.
